

# NAPA/SOLANO AREA AGENCY ON AGING MEETING PROTOCOL IN RESPONSE TO CORONAVIRUS COVID 19

California Governor Gavin Newsom issued Executive Order N-25-20 on March 12, 2020, relating to the convening of public meetings in light of the COVID-19 pandemic. The Napa/Solano Area Agency on Aging hereby provides notice that it will continue to convene its regularly scheduled public meetings of the Oversight Board and the Advisory Council telephonically, as provided in the publicly posted agenda notice, and until further notice. Pursuant to the Executive Order, and to maintain the orderly conduct of the meeting, the Napa/Solano Area Agency on Aging will allow Board members and Council members to attend the meetings telephonically and to participate in the meetings to the same extent as if they were present.

Members of the public who wish to participate may participate telephonically. For members of the public who wish to participate but not to attend telephonically, you may submit written comments on any matter within the Board or Council's subject matter jurisdiction, regardless of whether it is on the agenda for Board or Council consideration or action, and those comments will be entered into the administrative record of the meeting. To submit written comments by U.S. Mail or email for inclusion in the meeting record, they must be received by the Napa/ Solano Area Agency on Aging staff no later than 9:00 a.m. on the morning prior to the noticed meeting. **GUEST COMMENTS:** Laurie Hartmann, Executive Director, Meals on Wheels Solano County: Laurie reported that information gained from a survey of vaccinations in Solano County is being used by Public Health for mobile vaccination units, and to target training and information. Laurie reported that the Senior Coalition will no longer be an advisory board to the Solano BOS as of June 30, 2021, and that a core group of coalition members is looking at launching a non-profit. Lastly Laurie announced they are seeking nominations for Celebrating Older Adult Recognition Day coming up May 20.

# OLD BUSINESSS:

Richard White briefly provided Legislative updates including that a hearing on AB470 which addresses Medical Cal eligibility caps is scheduled for today.

#### **NEW BUSINESS:**

Can ACOA initiate initiatives to improve vaccination rates in Communities of Color? Donna Altes mentioned that the Council discussed coming up with recommendations at a previous meeting. Donna recognized that a number of efforts to address the issue are ongoing and asked if assisting in this effort is a priority and is feasible for the Council to tackle. Discussion included ideas to liaison with CanV regarding their efforts. Verneal Brumfield added that faith based groups have been quite active in this endeavor. Further discussion included ideas from Cheryl Johnson, Donna Harris and Deanna DuPont.


Elder Justice webinar sponsored by Ombudsman Services on April 21will focus on fraud and scam protection.

# FY 2021-2022 Funding Overview

# Total: \$3,157,051

Admin: \$242,928

Programs: \$2,914,123

- IIIB: \$683,255 (transportation, visiting, case management, peer counseling, legal, I&A, fall prevention)
- IIIC: \$1,540,251 (home delivered and congregate meals)
- IIID: \$35,166 (disease prevention evidence-based exercise and nutrition classes)
- IIIE: \$241,982 (family caregiver supports)

Elder Abuse: \$7,244 (Napa) Ombudsman: \$406,225 (Solano: \$244,865, Napa: \$161,360)

# Notable differences between 2020-2021 budget versus 2021-2022 budget allocations

# Net loss of \$367,531

- 1. Elimination of Families First funding (COVID) for senior nutrition: \$335,358
- 2. Elimination of Dignity at Home funding (OTO from State) for fall prevention: \$143,750
- 3. Increase of \$111,577 in Area Plan funding (\$96,793 Direct Services / \$14,784 Administration)

# **Program Changes – Continuation of COVID Services**

- 1. Senior Grocery Program in Solano -- \$10,000 (IIIB Supportive Services)
- 2. Emergency Services Program in Napa/Solano -- \$10,000 (IIIB Supportive Services)
- 3. Health Rx Program in Solano -- \$20,000 (IIIB and IIIC)

# Observations

- 1. Although senior nutrition providers will see a reduction in funding, both providers have remaining funds from the CARES Act to use before 9/30/21. Additional funding from the newly approved America Rescue program will arrive in the next few months, as well as anticipated increased state funding for meals with the new budget.
- Fall Prevention programs are funded using IIIB funding, although Meals on Wheels Solano is being reduced significantly – by \$35,518 – the program has remaining carry-over funds from Dignity at Home to use before 03/31/2022, and the new AAA contract will be supplemented by an additional \$20,000 from the Yocha Dehe Wintun Nation tribal grant.
- 3. Solano transportation grant will be cut by \$20,000 (from \$70,000 to \$50,000) due to
  - a. Change in ridership/reduced demand due to tele-med and fewer rides to senior centers. Per the provider, they expect this trend to continue.
  - b. Addition of low-cost, senior focused transportation programs through STA
  - c. Need to reallocate money to Fall Prevention services
- 4. Senior Grocery Program delivers grocery boxes to low-income seniors who may not qualify for the home delivered meal program or do not attend congregate dining sites.
